No. 5/146/2011-FD(TAX)(a): Whereas the State Government has felt the need for restructuring of Schedules appended to the Manipur Value Added Tax Act, 2004 as the items in the existing Act are categorised into only taxable and non-taxation items in Schedule-I and Schedule-II respectively and that there is no separate schedule for different categories of VAT rates and the items in the schedule are in random order with no elaboration. Attempt has been made to categorize the taxable items and to make more detailed and broad-based of items of IT products, Industrial input and packing material, capital goods including negative list.

Now, therefore, in exercise of powers conferred under Section 22 of the Manipur Value Added Tax Act, 2004, the State Government hereby makes restructuring and re-categorizing of the existing Schedule-I as Schedule-I(A), I(B), I(C), I(D), I(E), I(F) & I(G) placing all the taxable items under the above Sub-Schedules in alphabetical order with elaboration and Goods with 0% or Exempted VAT Rate are categorized in Schedule-II of the said Act as per Annexure.

This notification shall come into force from the date of publication in the official Gazette.
