**NOTIFICATION**

*Imphal, the 25th July, 2012.*

Tax/4(31)/CST/2012/~~113~~, Whereas it is considered necessary to extend the facility of filling declaration in Form C, F & H electronically to all the dealers registered under the Central Sales Tax Act, 1956 and to printout such declaration.

Therefore, in exercise of the powers conferred under sub-rule (1-B) of rule 4 of the Central Sales Tax(Manipur) Rules, 1957, it is hereby notified that, every dealer registered under the Central Sales Tax Act, 1956 shall make online requisition for declaration in Form C, F & H and shall be issued the declaration form in the following manner with effect from 1<sup>st</sup> Oct, 2012:

- (i) Every such dealer shall log on to the website [www.manipurvat.gov.in](http://www.manipurvat.gov.in), using the user name and password communicated by the Department.
- (ii) Every such dealer shall proceed to file his requisition along with all details and particulars of consignor and consignment for online issue of declaration in Form C, F & H.
- (iii) The declaration in Form C, F & H sought by the dealer would be approved /rejected by the concerned Issuing Authority. If approved, dealer can print such declaration Form in triplicate. Each declaration Form so printed will have a unique number assigned on it. If rejected, a fresh requisition for such form will have to be made by dealer.

Whereas, the online issuance of declaration in Form C, F & H shall be made operational with the following conditions:-

- (i) All offline issuance of the above mentioned Forms shall be discontinued with effect from 30<sup>th</sup> September, 2012.
- (ii) The inventories at the disposal of the Issuing Authority shall be surrendered to the Head of office (HOO) on the 1<sup>st</sup> October, 2012.
- (iii) The Forms already issued to the dealers prior to this Notification shall remain valid for use up to 31<sup>st</sup> October, 2012.
- (iv) Any Forms remaining unutilised in the custody of the dealers shall stand obsolete and invalid with effect from the 1<sup>st</sup> November, 2012.
